## Important Information

This Website Disclosure Information ('WDI') is designed to outline who we are and what we do, and to help you decide whether to use the digital financial services tool (SuperSizer) offered by Actuate Alliance Services Pty Ltd (referred to as "Actuate, us, we or our" in this WDI).

## Important documents you can expect to receive

If we provide you with personal advice we will present you with a written Statement of Advice (SOA). This will describe:

- any advice and strategies we recommend and the reasons why;
- the financial products and services we recommend and the reasons why;
- any fees or commissions we may receive; and
- any associations we have with financial product providers or other parties that may influence the advice we provide.

After that, any time we give you further personal advice, we'll give you (or keep on file), another written record of that advice. You can request a copy by contacting us any time up to seven years from the date the advice was provided.

To help you make an informed decision about a financial product you generally will be given a Product Disclosure Statement (PDS) which outlines the product features and costs in detail. In certain circumstances it is not a requirement that you be given a PDS (including, for example, where you already have one).

<p>Do Actuate staff receive any benefits?</p>	<p>Staff members are salaried employees of the Insignia Financial Group and in most cases, do not receive any proportion of any fees or commissions paid to Insignia Financial or any other company in the Insignia Financial Group in connection with the financial services or financial products referred to in this WDI. Staff members may be entitled to receive additional monetary or non-monetary benefits and/or rewards resulting from participation in programs conducted by Insignia Financial.
